1. Appellants' Motion for Rehearing was submitted pursuant to NMRA 1-074(U) which states:

A motion for rehearing may be filed within ten (10) days after filing of the district court's final order. The three (3)-day mailing period set forth in Rule 1-006 NMRA does not apply to the time limits by this rule. The motion shall state briefly and with particularity, but without argument, the points of law or fact that in the opinion of the movant the court has overlooked or misapprehended. No response to a motion for rehearing shall be filed unless requested by the court.

2. RGH's Motion for Leave to file Response is not appropriate under NMRA 1-074(U) because the Court has not requested any response to the Motion for Rehearing.

Similarly, Appellee's Response to Appellants' Motion for Rehearing filed December 3, 2019 is not appropriate.

- 3. Appellants do not object to the Court requesting responses to the Motion for Rehearing.
- 4. If the Court requests responses to the Motion for Rehearing, Appellants request that Appellants be allowed to present arguments on the seven points of law or fact which Appellants consider that the Court has overlooked or misapprehended, listed in Appellants' Motion for Rehearing.
